The conference will present fundamental outcomes of the project KapaCITY – supporting integration of foreigners at local level, identified good practices in provision of services to foreigners, as well as in their participation in local policy making, in municipalities participating in the project. Our overview will also introduce examples of inspirational and proactive practices from other municipalities who will speak about how they handle increasing numbers of inhabitants with migrant background. Each panel will host experts from abroad to introduce their models of inclusion worthy of adaptation in Slovakia.

At the end we will outline our lessons learned and identified challenges vis-à-vis integration of foreigners. At the end of each panel we would like to discuss possible ways forward and the role of municipalities in this area in the foreseeable future.

The event aims to gather representatives of municipalities, cities and regions and provide them with an opportunity to better understand why it is beneficial and far-sighted to pay attention to foreigners who settle in our cities in increasing numbers. They will learn what can be done in various areas to improve their integration, why it is necessary to take into account their specific needs and how it is organised by municipalities in both Slovakia and abroad. The conference may also be inspirational for central state authorities who initiate policies and legislation, for decision makers, including administrators of public funds. Last but not least, foreigners and host communities are very much welcome to take part.

### Preparation of Municipalities on How to Work with Foreigners
