



EVERYTHING YOU NEED TO KNOW ABOUT VACCINATION IN SLOVAKIA

Which vaccines are used in Slovakia?

Vaccine is available:

- Comirnaty from Pfizer / BioNTech (2 doses)
- COVID-19 Moderna vaccine from Moderna (2 doses), and
- COVID-19 vaccine Janssen (1 dose).

Vaccination against COVID-19 takes place in vaccination centers established in all districts of the Slovak Republic. It is also possible to be vaccinated in outpatient clinics or in mobile vaccination centers.

COVID-19 vaccination registration is open to all persons from 12 years of age.

Which of the foreigners living in Slovakia can be vaccinated and what documents do they need?

The following can be vaccinated: all foreigners residing in the Slovak Republic who

- have public health insurance and
- also foreigners without public health insurance who:
- have subsidiary protection granted, special pass VšZP
- are victims of trafficking of human beings in the program of the Ministry of the Interior,
- are medical students in the Slovak Republic who perform work in a hospital,
- have been granted temporary, permanent, long-term or tolerated residence in Slovakia,
 - a document (card) of a residence permit in the Slovak Republic or a card of a diplomat and a member of the staff of a diplomatic mission in the Slovak Republic
- are full-time university students in Slovakia from another EU Member State,
 - confirmation of a visit to a university in the Slovak Republic and the European Health Insurance Card
- are primary or secondary school pupils in Slovakia from another EU Member State,
 - confirmation of a school visit to the Slovak Republic and the European Health Insurance Card
- are asylum seekers in Slovakia
 - asylum seeker's card.
